## Proposed Constitution of Kenya (Amendment) Bill No. 4 of 2025.

NG-CDF Hearings: The National Assembly was scheduled to hold public hearings across all constituencies and counties from May 5th to May 7th, 2025, to gather views on the proposed Constitution of Kenya (Amendment) Bill No. 4 of 2025.

This bill seeks to entrench the National Government Constituencies Development Fund (NG-CDF), the Senate Oversight Fund, and the National Government Affirmative Action Fund (NGAAF) into the Constitution.

Members of the public are encouraged to actively participate and make their voices heard during these sessions.

The outcomes of these hearings will play a crucial role in shaping the final provisions of the amendment bill.

It plans to expand its services nationwide, offering lowinterest loans and support for cooperatives to boost productivity and food security.

The Cooperative Bank currently operates four branches in Moshi, Tabora, Mtwara and Dodoma with 58 agents. Plans are underway to open three additional branches in Dar-es-Salaam, Kagera and Mwanza.

## Finance Ministry Makes Concessions in 2025/26 Budget Following Parliamentary Feedback

The Ministry of Finance, Planning and Economic Development has made adjustments to the proposed 2025/26 national budget in response to concerns raised by Parliament. During a session on April 30, 2025, Finance Minister Hon. Matia Kasaija acknowledged the need for increased allocations to critical sectors, including agriculture, health, and education.

These concessions aim to address gaps identified by the Budget Committee and ensure that the budget aligns with national development priorities such as job creation, service delivery, and inclusive growth. The revisions also reflect a broader effort by the government to engage in transparent fiscal planning and accommodate input from key stakeholders, including civil society and local government representatives.

Lawmakers emphasized that budget responsiveness is essential for public trust and the effective delivery of services, particularly in underserved regions. The Finance Ministry has committed to continued dialogue with Parliament to ensure that the final budget is both equitable and economically sound.

Ethiopia has renewed its commitment to joining the World Trade Organization (WTO), aiming to finalize its accession in the coming months. Led by Ethiopia Ministers, the country is implementing wide-ranging economic reforms under its Home-Grown Economic Reform Agenda to align with WTO rules, including liberalizing key sectors and improving transparency in state-owned enterprises.

Ethiopia has made revised offers on goods and services and is actively engaging in bilateral negotiations with WTO members.

WTO officials and members have welcomed Ethiopia's progress and emphasized the need for continued efforts and concrete results, while development partners are stepping in to support capacity building and technical assistance.

These new players are joining established markets like the United States and Europe, helping to broaden Ethiopia's global presence and diversify its coffee export base. Leading revenue-generating destinations include countries in the Middle East, Europe, and North America, with Saudi Arabia, Germany, and the United States at the forefront. They are followed by Belgium, China, South Korea, the UAE, Japan, Italy, and Jordan. Collectively, these ten countries now represent 77% of total export volume and 78% of foreign exchange earnings from coffee.

The emergence of China, Jordan, and the UAE among the top importers reflects a shift in global coffee consumption trends and highlights the rising popularity of Ethiopia's specialty coffee. This expanded reach not only strengthens foreign exchange earnings but also reinforces Ethiopia's reputation as a leading player in the global coffee industry.

#### Ethiopia Achieves Record Coffee Export Growth with Expansion into 90+ Global Markets

The Ethiopian Coffee and Tea Authority has announced a significant milestone in the global expansion of Ethiopian coffee, with exports reaching record levels in both revenue and market reach, according to local news sources. Ethiopia has added over 30 new export destinations, increasing the total number of countries importing its coffee from 64 to more than 90—marking an unprecedented achievement for the sector. The Authority emphasized the growing international demand for Ethiopian coffee, particularly in emerging markets such as China and South Korea.
