#### **2025 Economic Survey**

According to The economic survey 2025:In 2024, Kenya's real Gross Domestic Product (GDP) grew by 4.7 per cent, compared to a revised growth of 5.7 per cent in 2023. The growth was noted in most of the sectors of the economy with Agriculture, Forestry and Fishing growing by 4.6 per cent compared to 6.6 per cent growth in 2023. Other sectors also had notable growths including Financial & Insurance Activities (7.6%), Transportation and Storage (4.4%) and Real Estate (5.3%). Construction however, recorded a contraction of 0.7 per cent down from a growth of 3.0 per cent in 2023. Similarly, mining and quarrying recorded a contraction of 9.2 per cent compared to a 2023 contraction of 6.5 per cent as evidenced in the reduced production of key minerals, including construction materials, titanium, salt (crude), and gemstones.

Kenya projects a 5.4% economic growth in 2025, following a slowdown to 4.7% in 2024. The 2024 deceleration was attributed to constrained government spending, high interest rates, protests, and adverse weather.

### Launch of Kenya National Public Health Institute (KNPHI)

Cabinet Secretary for Health, Hon Aden Duale, has officially launched the Kenya National Public Health Institute (KNPHI), marking a significant milestone in the country's efforts to enhance Universal Health Coverage (UHC) through preventive and promotive healthcare, and strengthen national health security.

Established under Legal Notice No. 14 of 2022, KNPHI will serve as Kenya's central platform for disease surveillance, health research, policy coordination, and rapid emergency response. The institute is expected to streamline public health functions, eliminate duplication, and improve Kenya's readiness and capacity to respond to health threats.

The launch of KNPHI signals a bold step towards institutionalizing data-driven public health decision-making and fostering stronger collaboration across health sectors. With this centralized approach, Kenya aims to build a more resilient health system capable of proactively managing current and emerging public health challenges.

### Safaricom posts Sh69.8 billion net profit

Safaricom has reported Sh69.8 billion in net income for the full-year ending March 31, 2025, as the telco registered double-digit growth in both mobile money and broadband. This, as Safaricom Kenya delivered a strong performance with total revenues hitting Sh381.2 billion, up 11.4 per cent compared to last year.



### Tanzania to Establish International Financial Services Centre (IFSC)



#### Tanzania Opens First CNG Station in Dar es Salaam

After press release, Tanzania's Deputy Minister for Energy, Judith Kapinga, has officially inaugurated a major Compressed Natural Gas (CNG) station in Dar es Salaam, capable of serving up to 1,200 vehicles per day. The station, managed by the Tanzania Petroleum Development Corporation (TPDC), is equipped with modern technology and will operate 24 hours a day. According to TPDC, the new facility is the second-largest CNG station in Africa and the largest in the East African region. Besides serving vehicles, it is also expected to supply gas to institutions such as schools, factories, and hotels using specially designed transport trucks. Government is in negotiations with the World Bank for new funding aimed at refurbishing 160 traditional secondary schools in the country, the Permanent Secretary, Ministry of Finance, Planning and Economic Development, Ramathan Ggoobi has said.

We are finalising negotiations with the World Bank for a big project we are bringing under U-Learn where most schools will be rehabilitated," said Ggoobi, who was appearing before the Budget Committee on Tuesday, 13 May 2025.

Ggoobi noted that the U-Learn Program together with the existing Uganda Intergovernmental Fiscal Transfer Programme (U-GIFT project) also funded by the World Bank, will go along away to boost the infrastructural needs in the education sector. 
